6 These accounts are prepared on an accruals basis. Subscriptions received are spread over the period to date of expiry, and any unused portion is deferred to the following year; most run to 31 December but a few members are yet to be regularised.

7 Transactions in the Australian dollar account are translated using the prevailing rate at the time of the transaction. Year end balances are translated at the closing exchange rate.

Treasurer's report

2013 saw relatively steady membership income; while we lost a few members, there were several new associations joining the fold. We hope some of the departing members can return when circumstances permit. There was a notable upsurge in rated tournament activity, yielding gross income of some \$2,300 which represents approximately \$1 per player per tournament. On the expenses front, aside from the regular remuneration to our webmaster and ratings officer, the major outgoing was an unrealised loss on the Australian dollar account (the Aussie dipped by over 16% in the period compared to the US dollar, in which these accounts are denominated). Our overall surplus was more than \$2,000, contributing to an increase in net assets backed primarily by bank and PayPal balances.
